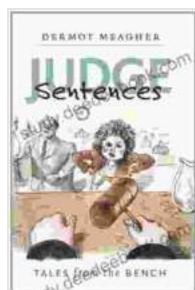


Judge Sentences Dermot Meagher to 20 Years for Assault and False Imprisonment

Meagher was arrested and charged with two counts of assault and one count of false imprisonment. He pleaded guilty to all charges on December 15, 2022.

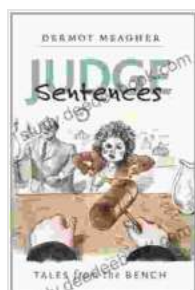

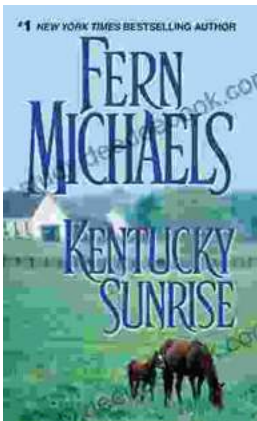
