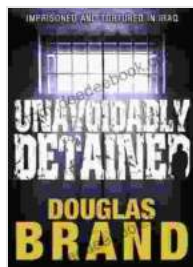


# Un(avoidably) Detained: Jodi Taylor's Imprisonment and the Fight for Justice

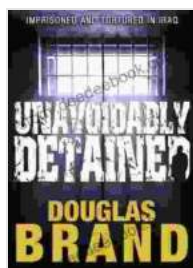
